

**WAYNE COUNTY SCHOOLS
PARENT PORTAL
ACCEPTABLE USE POLICY**

The Wayne County School System is offering the Infinite Campus Parent Portal to parents/guardians as a means to further enhance communication and to further promote educational excellence. The WAYNE COUNTY SCHOOLS Parent Portal allows parents/guardians to view their own child's records anywhere, anytime. In response for the privilege of accessing the site, every parent/guardian is expected to act in a responsible, ethical and legal manner. The WAYNE COUNTY SCHOOLS Parent Portal is available to every parent/guardian of a student enrolled in the Wayne County School District.

Parents/guardians are required to adhere to the following guidelines:

1. Parents/guardians will NOT share their password with anyone, including their own children.
2. Parents/guardians will not attempt to harm or destroy data of their own children, of another user, school district network, or the Internet.
3. Parents/guardians will not use the WAYNE COUNTY SCHOOLS Parent Portal for any illegal activity, including violation of Data Privacy laws.
4. Parents/guardians will not access data or any account owned by another parent/guardian.
5. Parents/guardians who identify a security problem with the WAYNE COUNTY SCHOOLS Parent Portal must notify the Wayne County School District or the local school immediately without demonstrating the problem to anyone else.
6. Parents/guardians who are identified as a security risk to the WAYNE COUNTY SCHOOLS Parent Portal or any other Wayne County School District computers or networks, will be denied access to the Parent Portal.

I understand that if I violate any terms of the Acceptable Use Policy that I may lose my privilege to use the WAYNE COUNTY SCHOOLS Parent Portal, and may be liable for civil and/or criminal consequences.
